### Membership classifications:

**Active Members:** The active class of member shall consist of physicians who have an interest in pediatric anesthesia and are eligible to be members of the American Society of Anesthesiologists.

**Affiliate A Members:** The Affiliate A class of membership shall consist of physicians practicing in the U.S. and Canada who are ineligible to be active members of ASA and non-physicians, who in each case have an interest in congenital heart disease, and are Affiliate members of SPA. Affiliate A Members shall not be entitled to vote on any matters submitted to the membership of the Section for a vote.

**Affiliate B Members:** The Affiliate B class of membership shall consist of physicians practicing in the U.S. and Canada who are ineligible to be active members of ASA and non-physicians, who in each case have an interest in congenital heart disease, but are not practicing or interested in pediatric anesthesia and are ineligible for membership with SPA. Affiliate B members will be shown as "Affiliate Members" on the membership record of the Section but not on the membership record of SPA. Affiliate B members shall not be entitled to vote on any matters submitted to the membership of the Section for a vote.

**International Members:** The International class of members shall consist of physicians who meet the qualifications for active membership but who practice outside the United States and Canada. International members shall have all the privileges of active membership. Please refer to the SPA website ([www.pedsanesthesia.org](http://www.pedsanesthesia.org)) to determine your tier.
